**Press release on the decision of the Higher Regional Court in Naumburg**

and

**Invitation to the International Press Conference of the Initiative in

**Where justice becomes unjust ...**

**On 23.10.2019 the First Criminal Tribunal of the Higher Regional Court (HRC) in Naumburg published its decision regarding the application of Mamadou Saliou Diallo for a court decision on the public prosecution for the murder of his brother Oury Jalloh.**

The court rejected his application and justified its decision by saying it would not meet the formal requirements on the one hand and on the other hand, it would be no founded, since the Public Prosecutor's Office in Naumburg had already "rightly denied" sufficient suspicion in its report of the 4th December 2018.

With this resolution the First Criminal Senate of the HRC in Naumburg places itself in all essential points together with the presented, unscientific and imaginative chains of argumentation that have been put forward by the Public Prosecutor's Office of Saxony-Anhalt. It closes itself against all facts and opinions of experts and reinterprets these into untenable convictions, which do not correspond to the reality.

Essentially, this resolution means the end of the legal Non-Clarification of the death circumstances of Oury Jalloh as well as two further deaths in one and the same police station by the responsible justice in Saxony-Anhalt.

As long as the truth has not been officially cleared up and the murderers of Oury Jalloh, Mario Bichtemann and Hans-Jürgen Rose are still unpunished and free, the files can/will not be closed. Where law is turned into obvious injustice by state institutions, where police officers can continue killing and burning people for racist motives, and where justice and politics want to protect these perpetrators\* by covering up facts – on the costs of the suffering and insecurity of the family – civil and independent clarification becomes a common duty!

**We therefore invite all interested media representatives\* to our International Press Conference on Monday, 28 October 2019, at which the "International Independent Commission for the Clarification of the Truth about the Death of Oury Jalloh" will present the results of a new radiological forensic report. This report contains new and reliable findings that provide further information about the circumstances of Oury Jalloh's death.**

**In addition, the results of the „International Analysis and Strategy Conference on Racist State Power and Structural State Rison“ held on the weekend of 26th and 27<sup>th</sup> of October 2019 will be presented together with affected family members from several European countries.**
